**ADDED:** Ability for providers and centers to add a **Developmentally Ready For Solid Foods** date for infants in the child details as well as new child enrollments.

**ADDED:** Ability for sponsors of providers and centers to add a **Developmentally Ready For Solid Foods** date for infants in the child details as well as new child enrollments.

**ADDED:** New policy (M.19) for center sponsors to warn or disallow on the claim if an infant is marked as developmentally ready for solid foods, but does not get served the correct number of components for a given meal. New error (101) will show if this policy is set to disallow.

#### KidKare for Centers

**FIXED:** Illinois state claim upload for centers fixed for centers with multiple programs.

**UPDATED:** **Child Participates** button in the child details has been renamed to **Child participates in food program**

**ADDED:** For Center Sponsors, **Policy T5** has been added. This policy allows the sponsor to ignore, warn, or disallow if a center has no receipts entered for the claim month.

**ADDED:** For Center Sponsors, a site setting has been added for **Require centers to enter receipts in order to submit claim** so sponsors can require receipt entry at the site level.

**ADDED:** A 4th custom field option was added for all open enrolled sites using the meal counter screen.

**ADDED:** New detailed meal delivery form added for open enrolled AtRisk sites.

**ADDED:** SFSP and AtRisk meal delivery report status has been added. Reports now show as **complete** or **pending**.
